

This TROPHY was donated by the NEW SOUTH WALES STATE COUNCIL of the AUSTRALIAN POWER BOAT ASSOCIATION in 2013 as a PERPETUAL TROPHY for ANNUAL competition for the AUSTRALIAN FORMULA 3 CHAMPIONSHIP SERIES class and shall be known as

**THE NSW STATE COUNCIL TROPHY**


1. The TROPHY shall be present to the WINNER of the AUSTRALIAN FORMULA 3 CHAMPIONSHIP SERIES, an EVENT open to tunnel hulls powered by outboard engines up to 1250cc, the Owners and Drivers of which must be Members of a Club affiliated with the Australian Power Boat Association.
2. The TROPHY shall be competed for ANNUALLY at such venue or venues as the conducting Club and the Australian Power Boat Association may decide at its Meeting where Australian Championships are allocated for the following season.
3. The contest shall be under the control of the Australian Power Boat Association whose decision in all respects shall be final and the said Association shall have the power from time to time to alter or amend the rules and regulations governing the contest, not inconsistent with this Deed.
4. The class shall be restricted to tunnel hulls powered by outboard engines up to 1250cc in capacity or other such engines that meet the rules as approved by the Australian Power Boat Association.
5. The Event shall be conducted on different configuration course as defined by the conducting Club and the Standard Course, as defined in the Rules of the Australian Power Boat Association.
6. The TROPHY shall be vested in the Australian Power Boat Association, but possession of the TROPHY shall, from time to time be by the Club, or Owner of the winning boat, which represented such Club at the last competition, subject to its safe custody as, may be deemed reasonable by the Australian Power Boat Association.
7. The TROPHY shall be returned prior to the contest each year, as stated in the Rules of the Australian Power Boat Association. Such Council, Club or Person taking possession of the TROPHY shall be deemed to have received such TROPHY in good condition unless a report is furnished to the NATIONAL SECRETARY of the Australian Power Boat Association, within fourteen (14) days, stating otherwise.
8. The Council or Club conducting the contest will make available a suitable Winners trophy and trophies for Second and third place getters.
9. Championship Certificates are to be provided by the Australian Power Boat Association in accordance with the current Rules, but the INSCRIPTION on the TROPHY shall be the responsibility of the winning Owner.

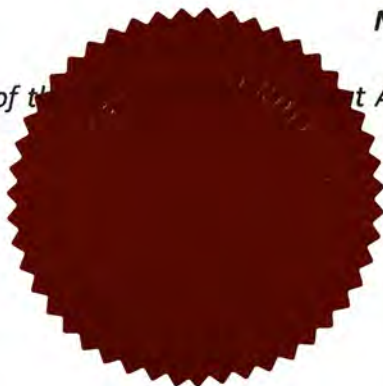


